Terms and conditions of the Livinfrance scholarship program

English version The <u>French version</u> prevails over the English version

Article 1: Object

EDEN INITIATIVE, SAS with a share capital of 4 200 (four thousand two hundred) euros, registered in the Lille TCR under n° 812 904 928, with registered office at 165 Avenue de Bretagne Euratechnologies, 59000 Lille (hereinafter : "Eden Initiative" ou "Organizing **Company**"), operating the Livinfrance brand and sites, is organizing a scholarship program from March 1, 2023 at 12:00 a.m. to June 30, 2023, at 11:59 p.m. (French date and time), hereinafter referred to as "Program".

The purpose of these rules (hereinafter: "Rules") is to define the rights and obligations of the Organizing Company and the applicants for the scholarship (hereinafter the "Applicant(s)").

Article 2 : Eligibility requirements

To be eligible for the Program, the Applicant must meet the following criteria :

- Level of study: All levels of higher education (as defined in the article L612-1 of the Code de l'Education) are allowed to apply.
- Field of study: All fields of study are allowed to apply.
- Age: No age limit. Applicants who are minors (according to French law) must provide proof of a legal representative.
- Nationality: All nationalities are allowed to apply, except for French students. 0



- Cumulative grants: Allowed
- Institutions/trainings: Applicants must be able to prove acceptance into a French higher education program to be eligible. Only courses and trainings recognized by the French government are eligible.
- Application origin: Only applications sent through the <u>"Livinfrance 2022-2023</u> <u>Scholarship Application"</u> form will be considered.
- **Duration of the study stay:** Applicants must stay in France for their studies for a duration longer than or equal to 3 (three) months.
- Additional requirements: The Applicant must be able to prove a personal user account on the livin-france.com platform in order to validate their application. *Please note that the creation of an account is free of charge and does not require any device/hardware that could discriminate against the Applicant.*

Each Applicant may submit **only one application** through the online application form.

In any event, all information provided by the Applicant in the Application form must be accurate. **It is the responsibility of the Applicant to ensure the accuracy of the information provided in the Program**. Any application form that is filled out incorrectly, incompletely or contains inaccurate information will not be considered and will result in the invalidity of the application, at any stage of the selection process.



Article 3 : Selection process

Application

All Applications must be sent though the **"Livinfrance 2023 Scholarship Application" form**, available only on the following URL: <u>bourse.livin-france.com/formulaire-2023</u>. Eden Initiative declines all responsibility in case of phishing or identity theft (as defined in the articles 313-1 and 226-4-1 of the French Code Pénal) by third parties.

Application sent by other means will not be considered and will be automatically rejected. Any incomplete application will be rejected.

Applicants must be able to justify a personal account on **livin-france.com** platform, created before June 30th, 2023 in order to validate their application.

Shortlist

Information concerning the academic, economic and social situation of the Applicant will be requested in order to make a **first selection of Applicants**.

The Applicant is responsible for the accuracy of this information.

This first selection will be made exclusively on the basis of this information, at the sole discretion of Eden Initiative. Shortlisted Applicants' file will be presented to the jury in order to select the laureates of the Program.

Selection of the Scholarship recipients

The selection of the Scholarship recipients is made by an independent jury, composed of international mobility actors, whose composition will be communicated to the Applicants by July 1st 2023 at the latest.



In order to proceed with the selection of the Scholarship recipients, a motivation form will be forwarded to the shortlisted Applicants, and only applications submitted through this form will be considered by the jury. Shortlisted Applicants may attach additional documents to support their application :

- Motivation letter/video
- Recommendation letter
- Transcripts from the last 3 years
- Any other document that may support their application

Form must be returned within 3 (three) days after receiving the validation email for shortlisted Applicants.

The jury will follow a rating scale, based on the following criteria, in order to assess applications :

- Personal and professional project of the Applicant
- Relevance of the mobility project
- Academic quality of the file
- Extra-curricular activities

The evaluation of the Applicants according to this scale is left to the discretion of the jury members.

Files thus selected will constitute the final list of Scholarship recipients.



Article 4 : Announcement of results

Scholarship recipients will be announced during a live session, in attendance of Livinfrance Scholarship partners and jury members. It will be broadcasted on **July 18th**, **2023.** Link will be communicated later.

The date of announcement of results is communicated for information purposes only. The Organizing Company may, at its sole discretion and without notice, change the date, form, and manner of announcement of the Scholarship recipients. In the event of a change, the Organizing Company will inform the Applicants as soon as possible.

Each Scholarship recipient will receive an e-mail containing the terms and conditions for receiving the services, and a link for making an appointment with a Livinfrance agent for the rest of the procedure.

Scholarship recipients will have 15 days from the reception of this e-mail to confirm their acceptance and confirm or communicate their complete contact information in order to receive their benefits.

The Organizing Company may not be help in the event of non-delivery of this e-mail as a result of an error in the e-mail indicated by the Applicant in their form, a change in their contact details, a failure of their access provider, a failure of their Internet network or for any other reason.

If the Scholarship recipient fails to notify us within 15 days after reception of this e-mail, the Scholarship recipient will be considered to have purely and simply renounced their benefits. The benefits will not be awarded to them and cannot be claimed at a later date under any circumstances. It will be kept and will remain the property of the Organizing Company without this being able to be the subject of any claim.

No transfer or postponement of the scholarship is possible.



Non-selected Applicants will also be informed by e-mail.

Article 5 : Expected benefits

The value of the benefits is determined at the time of writing these Rules. This value may not be redeemed, exchanged or returned for any reason whatsoever.

For the "installation grant in France", the benefits provided are

Housing

Each Scholarship recipient will benefit from personalized assistance in his or her search for housing, the creation of his or her rental file and will be offered the reservation fees for LivinFrance certified housing **in the amount of €595** (maximum price noted on the LivinFrance reservation fees).

For the Scholarship recipients who have already made a LivinFrance reservation, the reservation fees will be fully refunded **exclusively on the payment method used for the reservation**.

The start date of the rental contract must be **between 01/06/2023 and 31/12/2023**, and the rental period must be **at least 3 (three) months in Lille and 8 (eight) months for the other cities in France.**

Civil liability insurance

Each Scholarship recipient will be offered a Livinfrance civil liability contract **worth €40** (maximum price noted).

The contract will start on 01/08/2023 and will expire on 01/08/2024.

Home insurance

Each Scholarship recipient will be offered the first 3 months of their home insurance **worth €50** with the partner company Luko, SASU registered with the RCS of Paris B under the number 837 821 149.

The start date of the contract must be specified by the student and **must be between** 01/06/2023 and 30/12/2023.

Personalized support

A personalized accompaniment worth **€250** (maximum price noted) will be offered to each Scholarship recipient. A Livinfrance agent will be assigned to each Scholarship recipient in order to assist them in all administrative procedures (CVEC, CAF, French health insurance, validation of VISA and first application for a residence permit).

Each Scholarship recipient will thus receive a complete package worth €1,000 for their study stay in France.

For the "Scholarship for studies in France" the benefits provided are :

Tuition fees

1000€ reimbursed on the tuition fees, only if the application and acceptance have been made to the Livinfrance service https://edu.livin-france.com/

No personal data is collected automatically on the bourse.livin-france.com website. The personal data of the Applicants will be communicated exclusively to the members of the jury by the Organizing Company. To this end, the Organizing Company and the jury members are responsible for maintaining the confidentiality of such data.

Applicants' personal data collected during the Program will be kept for 1 year and will not be sold to third parties under any circumstances.

In order to validate their application, Applicants will be invited to register on the livinfrance.com website, and on this occasion, to accept the <u>privacy policy of the livin-</u> <u>france.com website</u>, which is separate from this one. In accordance with the French Data Protection Act of January 6, 1978, as amended, and the General Data Protection Regulation (EU) 2016/679, you have the right to access, rectify and delete data concerning you. You can request the portability of the latter. You also have the right to object to the processing carried out or to request the limitation thereof.
